The reports of the President, Secretary, Communication Officer, and Treasurer are presented. Noteworthy:

- The President reports standing problems in mineralogical publishing strategies. The
 proposal of a new mineralogical journal is set in standby because of the prospected costs
 (appx 70.000 US\$/year) and managing issues. Patrick Cordier (the new elected president)
 heads a commission on publication issues and ethics that is meant to address these issues.
 Anyone who wants to be involved or send suggestions should address Cordier.
- David Bish is stepping down as Treasurer. The Association is looking for a new Treasurer, possibly based in the US because of banking problems in money transfer abroad.

The IMA Medal Committee presents the list of medalists.

The Council Members standing for re-election (Marco Pasero, Anhuai Lu) or election (Sergey Smirnov) are introduced.

Annamária Kis reports on the IMA archive located in Budapest: All IMA documents, minutes, and Abstracts are going to be stored and available on line. The Encyclopedia of Minerals (Mandarino) should also be inserted in the future. Documents from the early Mineralogical congresses can be sent to Kris to be scanned and included.

 Commission.
- Patrick Cordier reminds the activity of the "IMA working group on scientific publications and ethics". The working group needs feedback from the mineralogical community on the issues of publication strategies, low impact factor of mineralogical journals, etc. Cordier warmly invites interested mineralogist to participate to the working group with suggestions and proposals.
